Probationary Members will pay £3 or £5 (depending upon the type of Shoot) more than Full Members at each shoot they attend during the Probationary Period, the length of which shall be dependant upon their safety and conduct at Shoots.

Section 21 of the Firearms Act 1968

Under a Home Office ruling (effective 01/01/1996) prospective members, members and guests must sign a Declaration that they are not prohibited from possessing or using a firearm or ammunition by virtue of Section 21 of the Firearms Act 1968.

Section 21 applies to anybody who has been sentenced to imprisonment or youth custody or detention in a young offender institution for 3 months or more.

The period of prohibition depends upon the length of sentence.

If the sentence was for 3 months or more, but less than 3 years, the prohibition lasts for 5 years from the date of release.

If the sentence was longer than 3 years, the prohibition lasts for life.

It is an offence for any person to transfer, let on hire, give or lend a firearm or ammunition to someone whom he/she knows or has reasonable ground for believing to be prohibited by Section 21 of the Firearms Act 1968.
